

# 2019-20 BOG Program Review Specific Action Follow-up

## School of Medicine

### BS Exercise Physiology: Partially Resolved

- Assigned a follow-up action to reduced credits in AOE and have appropriate number of upper-division credits
  - Changed to 13 credit hours with 9 at the upper-division level
- Assigned a follow-up action to adjust balance of lower and upper-division courses in major to meet academic definition
  - Working with Registrar's Office on a larger issue of displaying *school* requirements separately from *major* requirements. Major requirements meet the academic definition.
- Assigned a follow-up action to revise learning outcomes to be more measurable
  - Delayed until Dec 2021 to align with follow-up action on assessment and with hiring of new faculty member to oversee overhaul of program assessment

## College of Creative Arts

### BA Art History: Unresolved

- Assigned a follow-up action from AY 18-19 to address faculty shortage
  - There are now only two faculty for the whole program putting the students in the program at risk of completion should one leave
- Assigned a follow-up action from AY 18-19 to address low enrollment
  - Enrollment for AY 18-19 was dramatically improved

## Eberly College of Arts and Sciences

### BS Sociology: Resolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - Plan and evidence of implementation were submitted and approved

## Chambers College of Business and Economics

### BS Economics: Unresolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - The new chair had not been informed of the follow-up action and the previous chair had taken no steps towards addressing the issue
    - Follow back up in Dec, 2020

### BS Accounting: Unresolved

- Assigned a follow-up action from AY 17-18 that required submission of evidence of improvement to CPA pass rates
  - Data submitted showed moderate improvement in AY 17-18 but at the time of submission the program did not have data for AY 18-19. CPA pass rates had improved from 42% to 46%, still below the national average of 48% but above the state average of 41%
    - Follow back up in Dec 2020 for AY 18-19 CPA pass rates

### BS Marketing: Unresolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - Submitted an assessment plan and curriculum map that were reviewed and approved but no evidence of assessment
    - Follow up for evidence of assessment in Dec 2020

## Potomac State College

### AAS Business Management Technology: Partially Resolved, Partially Unresolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - Submitted an assessment plan that was reviewed and approved but had no evidence of implementation due to faculty turn over
    - Follow up for evidence of implementation in Dec 2020
- Assigned a follow-up action to improve number of graduates in the program
  - Program graduates increased significantly each of the two years since the program review

### AA Business Administration: Resolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - Plan and evidence of implementation were submitted and approved

## WVU Tech

### BS Business Management Technology: Resolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - Plan and evidence of implementation were submitted and approved

### BS Chemistry: Resolved

- Assigned a follow-up action from AY 17-18 that required the submission of an assessment plan with at least one year of evidence of assessment
  - Plan and evidence of implementation were submitted and approved

- Assigned a follow-up action from AY 17-18 that required the submission of evidence of improved enrollment and completion numbers
  - Both enrollment and completion numbers have significantly improved since the move to the Beckley campus

#### BS Biology: Resolved

- Assigned a follow-up action from AY 18-19 that required the submission of evidence of resumed assessment
  - Evidence of assessment was submitted and approved
